The undersigned acknowledges that under the provisions of the applicable tax regulations, the Foundation Trustees have the power and the duty to modify any restrictions or condition on the distribution of funds for any specified charitable purpose if, in its sole discretion, the recipient has

become, in effect, unnecessary or incapable of fulfillment or inconsistent with the charitable needs of the community.

If the foregoing is acceptable to the Foundation, kindly so indicate by dating and signing the enclosed copies of this letter in the space provided and return one to my attention. Upon such acceptance, this letter will constitute our agreement with respect to the Name of Fund and all prior discussions and agreements concerning the Fund are merged herein and are made a part hereof.
