Dear Board of Trustees:

I/We have delivered as an irrevocable gift to the Homer Foundation, a tax exempt organization as described under Subsection of 501(c)(3) of the Internal Revenue Code, the property described in Schedule A hereof. It is my/our request that such gift, together with any additional gifts which may hereafter be made by me/us or other donors to the fund hereafter described, be used to establish and maintain the Name of Fund (the “Fund”) of the Homer Foundation (the “Foundation”) to be held and administered as follows:

1. Name of Fund shall be known and identified as such by the Foundation and its Trustees in the course of the administration and distribution thereof.
2. Distributions from the Fund shall be distributed at least annually for:
3. Distributions as provided in paragraph 2 shall be consistent with the Homer Foundation’s Spending Policy. However, the Foundation Trustees may, if they consider unusual circumstances to exist which make it advisable to invade principal, authorize distributions from the principal of the Fund for the purposes as provided in 2 above.
4. Notwithstanding anything herein contained to the contrary, the Fund shall at all times be held and administered in accordance with the provisions of the Articles of Incorporation, Bylaws, and Policies of the Foundation and applicable tax regulations, as they now exist or as they may be amended, including those provisions relating to amendment, termination and variance from the fund’s purpose. The undersigned acknowledges that under the provisions of the applicable tax regulations, the Foundation Trustees have the power and the duty to modify any restrictions or condition on the distribution of funds for any specified charitable purpose if, in its sole discretion, the recipient has become, in effect, unnecessary or incapable of fulfillment or inconsistent with the charitable needs of the Homer community.

If the foregoing is acceptable to the Foundation, kindly so indicate by dating and signing the enclosed copies of this letter in the space provided below and return one to my attention. Upon such acceptance, this letter will constitute our agreement with respect to the Name of Fund and all prior discussions and agreements concerning the Fund are merged herein and are made a part hereof.
